MOBILITY TRACKS

Students can choose to begin the first year of the programme either in English at the School of Health and Related Research - University of Sheffield (UK), or in Spanish at the Andalusian School of Public Health – University of Granada (Spain). The year 2 specialisation course has to be followed in a different country than Year 1.

PARTICIPATION COSTS

The Consortium has agreed the following participation costs, irrespective of the pathway followed, for the two-year course:

- €11,000 for European students
- €14,000 for Non-European students

Europubhealth aims to produce graduates who are able to:

- Analyse and address the determinants of health problems from a population perspective.
- Propose, plan, implement and evaluate culturally appropriate, evidence-based policies and interventions for the effective improvement of population health in international, national, and local contexts.



ACCESS PROFILES AND CAREER OPPORTUNITIES

Interdisciplinary by nature, Europubhealth is open to students with diverse but complementary profiles drawn from medical sciences (including doctors, nurses, veterinaries, pharmacists...), social science (including sociology, economics, psychology, anthropology, geography, political sciences, law...) and engineers.

Depending on the specialisation, students are trained to undertake different public health functions such as health surveillance and protection, health promotion, planning and regulation, organising, delivering and evaluating the effectiveness of health services.

AWARDED DEGREE

The Consortium will offer a **double degree** recognised and composed of two national degrees delivered by the year 1 and year 2 Institution. In addition, the Consortium issues a **Europubhealth certificate** and a **Joint Diploma Supplement** to successful students.

ADMISSION CRITERIA

To be eligible, applicants must fulfil the following conditions agreed by the Consortium:

- Having at least a **university Bachelor degree or recognised equivalent** (180 ECTS) in one of the disciplines mentioned in the access profile.
- Being **proficient in the languages** suitable for the mobility combinations chosen (English; English + Spanish; English + French; Spanish + English + French):
 - **C1 English** for the foundation course in Sheffield
 - **B2 English** for specialisations in English
 - **B2 English** for Integration Modules in Rennes
 - **B2 French**
 - **B2 Spanish**
- Studying **full time** during the two years of the Master course
- Submit a **complete online application form** in <http://emundus.izp.cm-uj.krakow.pl> and provide all the supporting documents required (diplomas, certificates, language certificates, letters of recommendation etc.) **before the deadline.**
